



Note: Overall church giving decreased in FY 2020. Actual monthly donations in FY 2021 seem to be consistent and increasing as churches continue to re-gather following COVID-19. Using average monthly giving numbers, we estimate by the end of this fiscal year (August 31, 2021) donations will total \$197,011. We project that donations will improve and/or meet the current level of giving to SYBA in the new year and thus provide more than enough to fund the proposed budget for FY 2022 at \$188,000.

4029 - Harmony This fund is used for ministry and the upkeep of

facilities for a church plant in Harmony. Donations come from the NC Baptist State Convention, SYBA

churches, and individuals.

BYLAWS OF THE

SOUTH YADKIN BAPTIST ASSOCIATION, INC.

A NONPROFIT CORPORATION

ARTICLE I: NAME

The name of the Corporation shall be the South Yadkin Baptist Association,
Incorporation herein and after known as the Association.

ARTICLE II: MEMBERSHIP

Section 1. This Association shall be composed of regularly constituted Southern Baptist Churches who have been duly accepted into membership by the Association.

Participating member churches may empower the Pastor and up to two other representatives to vote on matters at the Annual Session or other special called meetings.

Section 2. The Association shall be sole judge of its membership and may receive or reject churches applying for membership therein at its pleasure, provided that the churches so received shall agree to come under watchcare of the Association for a period of one year. During this period of watch care, such church or churches shall be entitled to all the rights and privileges of the Association except that of their members voting and holding office. At the conclusion of this period, should no objections be raised, they then, upon recommendation of the Board of Directors, would be presented to the Association for membership in regular standing by action of the Association in Annual Session.

Section 3. The Bible shall be accepted as the sole guide in matters of doctrine and practice, and the Association shall reserve the right to withdraw fellowship from any church that does not conform thereto.

ARTICLE III: PURPOSE

The primary purpose of this Association shall be to counsel together for the advancement of the cause of Christ for the promotion of unity and growth among the churches composing the Association; furthermore, it is the purpose of this Association to cooperate with the Baptist State Convention of North Carolina and the Southern Baptist Convention and their agencies in the work of missions, Christian education, and social ministries.

ARTICLE IV: POWERS AND PREROGATIVES

The Association shall have no power whatever to infringe upon the autonomy of the churches. It may advise or recommend measures of guidance for their adoption but cannot bind them in any way. All the churches constituting the Association remain sovereign and independent bodies and unite that they may more effectively promote the cause of Christ throughout the world.

ARTICLE V: DUTIES OF THE CHURCHES

Section 1. It shall be the duty of each church to select representatives and to encourage their attendance at the Annual Sessions of the Association (See Article II: Section 1.)

Section 2. Each church shall send annually a report, the Congregational Profile, to the Association giving information requested. This information, in turn, will be shared with the Baptist State Convention of North Carolina and the Southern Baptist Convention.

Section 3. Each member congregation is expected to financially support the Association. It is recommended that each member congregation establish a certain percentage of their undesignated receipts to be forwarded to the Association monthly.

Section 4. Each member congregation is expected to participate in the ministries and the mission activities of the Association.

ARTICLE VI: ORGANIZATION

Section 1. The Board of Directors of the Association shall be a President, Vice-President, and five Board members, who shall be elected at the Annual Session. The Associational Clerk and the Associational Executive Director shall serve as ex-officio Board members and shall serve at the pleasure of the Association. The Board of Directors shall recommend all officers to be elected by the Association in the Annual Session.

Section 2. All officers shall be members of churches affiliated with the Association.

ARTICLE VII: DUTIES OF OFFICERS

Section 1: It shall be the duty of the President to preside when the Association is in session and in other meetings as provided for in these Bylaws.

Section 2. It shall be the duty of the Vice President to preside in the absence of the President and to assist the President in every way possible.

Section 3. It shall be the duty of the Clerk to keep an accurate record of the Session of the Association and prepare minutes to be distributed within two months after the Annual Session or as soon thereafter as possible.

Section 4. The Board-designated Financial Officer shall be responsible for an accurate account of all money paid into the Association, payment of corporate obligations, shall make regular reports to the Board of Directors and make an annual report to the Association. The Board of Directors shall enlist the services of a CPA to

conduct a financial review every three years. Such cost being reimbursed by the Association.

Section 5. It shall be the duty of the Clerk to collect and preserve minutes of each session of the Association and to collect and preserve records of the history of our Association.

Section 6. Any vacancy which occurs in the Board of Directors shall be filled by the Board of Directors.

ARTICLE VIII: RULES OF ORDER

In the absence of the President, the Vice-President shall preside at all regular meetings. All officers shall faithfully discharge the duties pertaining to the office to which they have been elected. The following rules shall govern deliberations:

- 1. All business shall be conducted and all discussions shall be carried out in a Christian manner as prescribed in the Scriptures.
- 2. The method of voting shall be by the will of the body. The simple majority shall prevail in all cases, except as otherwise designated by the Board of Directors.
- 3. A ruling by the presiding officer shall be final unless appeal be made from such rulings to the entire body present.

ARTICLE IX: TIME OF MEETING

The Association shall meet annually in August; however, in the case of some unavoidable circumstances that make a change in the date necessary, the Board of Directors is empowered to make such a change. The Board of Directors shall have the authority to call a special meeting of the Association should the need arise.

ARTICLE X: THE ASSOCIATION YEAR

The fiscal year shall begin with the first of September of each year and close the following August 31.

ARTICLE XI: BOARD OF DIRECTORS

- 1. Membership. The Association shall have at least seven (7) Directors. The seven (7) Board of Directors shall consist of President, Vice President, and (5) five other Board members who shall be elected at the Annual Session. These officers will be elected by the Board annually. The seven (7) duly elected Board of Directors can designate additional at-large Directors as deemed necessary.
- 2. <u>Duties</u>. The Board of Directors shall have general control of the affairs, funds, and property of the Association and shall determine policy and establish guidelines for the effective conduct of the business affairs of the Association. It shall be responsible for the accomplishment of the organization's purposes and objectives and shall present to the membership all proposed major program activities for ratification. The Board of Directors shall recommend the officers of the Association herein described.
 - 3. Fiscal Powers. The Board shall oversee the budget for each fiscal year.
- 4. <u>Term of Office</u>. The Directors shall be elected annually. They will serve rotating 4-year terms and must be off the Board for 1 year before they are eligible to serve another term. Vacancies occurring between annual sessions of the Association shall be filled by the Board of Directors.
- 5. <u>Removal</u>. Any Director may be removed without cause by a majority vote of all other Directors.

ARTICLE XII: CALLED OR SPECIAL MEETINGS

- 1. Special meetings of the Board may be called by the President, Vice-President, the Executive Director, or any three (3) Directors. Special meetings shall be held on four (4) days notice by first-class mail, postage prepaid, or on forty-eight (48) hours' notice delivered personally, by telephone, or by electronic mail. Notice of the special meeting need not be given to any Director who signs a waiver of notice or a written consent to holding the meeting or an approval of the minutes thereof, whether before or after the meeting, or who attends the meeting without protesting, prior thereto or at its commencement, the lack of such notice to such Director. All such waivers, consents, and approvals shall be filed with the corporate records or made a part of the minutes of the meeting.
- 2. <u>Time and Place</u>. The time and place of the meetings of the membership shall be as specified by the Board of Directors.
- 3. <u>Special Meetings</u>. Special meetings of the Association may be called at the request of a majority of the Board of Directors.
- 4. <u>Notice of Meetings</u>. The Clerk shall notify each member of the time and place of all meetings called for by the Board of Directors. Such notification may be written or verbal communication with the membership.
- 5. <u>Quorum</u>. A simple majority of the members present at a meeting shall constitute a quorum at membership meetings.

ARTICLE XIII: LIABILITY

The private property and assets of members of the Board of Directors, officers, committee members, employees, and agents of South Yadkin Baptist Association, Inc.,

shall forever be exempt from liability for its debts, obligations, and lawsuit and shall be entitled to indemnification as provided for by N.C.G.S. 55 A-8-50, et seq.

ARTICLE XIV: NET EARNINGS

No part of the net earnings of the organization shall inure to the benefit of its members, directors, officers, or other persons except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the exempt purposes of the organization.

ARTICLE XV: ADOPTION

These Bylaws shall take effect immediately upon its adoption and shall supersede any and all Bylaws previously adopted.

ARTICLE XVI: REVISION

These Bylaws may be immediately revised at any session of the Association by a vote of two-thirds of the representatives present.

ARTICLE XVII: CORPORATE SEAL

The Corporate Seal of the Association shall consist of two concentric circles between which is the name of the Association and in the center of which is inscribed the word "SEAL" and such seal, as impressed on the margin hereof, is hereby adopted as the Corporate Seal of the Corporation.

NC BAPTIST FOUNDATION ANNUAL REPORT (2020-2021)

The North Carolina Baptist Foundation is an agency of the Baptist State Convention, "Fostering Generosity...Facilitating Kingdom Growth."

OUR MISSION: "...Committed under the guidance of the Holy Spirit to serving North Carolina Baptists and others in generating an increased awareness of Christian estate principles as a means of financially undergirding Baptist churches, institutions and mission endeavors on a permanent basis."

Since 2008 when NC Baptist Financial Services was established we have this added mission: ..."to serve the needs of NC Baptist churches, Baptist institutions and members of NC Baptist churches by providing loan and investment services."

Even during a time of pandemic the Lord has blessed in a great way:

- New Accounts- 24
- Total Gifts- \$4,463,992.00
- Total Distribution- \$9,864,465.00
- Awarded 204 Baptist Student Scholarships Totaling over \$400K
- Current Assets Managed- \$184 million
- 89 Church Loans Totaling over \$45.5 Million
- \$65 million in Certificates of Participation

The Foundation is in the third year of a partnership with PhilanthroCorp to provide estate planning services for NC Baptist pastors and others. In the following report you can see the potential Kingdom impact when encouraging and facilitating estate planning with a focus on remembering Kingdom causes:

- Provided funding for some 32 individuals to be taken through the estate planning process
- This has resulted in some \$10 million in planned charitable gifts, with almost \$8 million designated for Baptist causes
- The majority of those charitable gifts coming to NCBF in the form of permanent endowments and charitable trusts

The Lord also blessed our ministry of investing Kingdom assets while at the same time screening for holdings in alcohol, pornography, gambling or the abortion industry. The following investment report tells the story:

Combined 2019 and 2020 returns:

We also continue to pray and plan for new ministries to meet the needs of NC Baptist churches in our effort to be on mission together:

- Continue to study the feasibility of establishing a capital campaign ministry for NC Baptist churches
- Make church loans in all 100 counties in North Carolina. To date we have made loans to churches in 55 counties
- Offer grants to new church starts
- Conduct one day seminars across our state on the subject of Legal Issues for Pastors and Church Staff. Topics to include:
 - "How to Evaluate Church Insurance Needs and Coverages"
 - "Church Governance and Organization"
 - "Church Personnel Policies"
 - "How to Conduct a Meeting"
 - "Should the Church Adopt a Safety Policy"
 - "When is a Gift NOT a Gift"
 - "Constitutional Rights and Issues for a Church"
 - "How to Safely use Church Websites and Social Media"
 - "Does Being a Pastor mean you are also a Counselor"
 - "Preparation and Use of Permission/Medical Forms"

In 2020 the Foundation celebrated its 100th anniversary and the blessing of distributing \$200 million to mission and ministry causes over our first 100 years. With God's continued blessings and NC Baptists faithful stewardship, we anticipate distributing the next \$200 million in just the next 20-25 years. To God be the glory, great things HE has done! And we are confident of even greater things HE will do in the years ahead.

Compensation and Benefits Services (CABS)

The Compensation and Benefits Services (CABS) office provides answers to general questions about retirement, insurance, and other financial and tax needs of our churches. Our goal is to keep our local N.C. Baptist associations and churches in compliance with the tax laws and up-to-date on changes that affect them. The following information is a summary of those efforts.

Federal Tax Legislation

Since the passage of the CARES Act in March, 2020, Congress has continued to make an effort to stimulate the economy by passing several pieces of legislation that continue to have a positive impact for our churches and their members. First, Congress passed the Disaster Tax Relief Act in September 2020, which extended over two dozen expiring tax credits. In December 2020, Congress passed the Consolidated Appropriations Act of 2021 that provided eligible taxpayers with a second stimulus check, and it made significant changes to the Paycheck Protection Program (PPP) and the Employee Retention Credit (ERC).

The Consolidated Appropriations Act extended the PPP loan program and provided eligible borrowers an additional \$284 billion through a second draw. The act also eased the reporting requirements for loan forgiveness especially for loans that did not exceed \$150,000. Federal unemployment benefits were extended through Dec. 31, 2020, but the benefits were reduced to \$300 per week rather than \$600. The ERC was expanded through the end of 2021 and allowed employers who had received a PPP loan to apply for the tax credits. The American Rescue Plan, signed in March 2021, allowed most 2020 recipients of unemployment compensation to report the first \$10,200 of the benefit as not taxable, provided a third stimulus check to qualified taxpayers, and provided other enhanced child tax credit benefits.

Retirement

The CABS office works with church staff and lay leaders to assist them in structuring of pastor and staff compensation packages to include retirement benefits. Many pastors and staff members do not see the benefits of participating in the Church Retirement Plan, and they will opt out of the plan if given an opportunity. Therefore, a continued effort is being made to challenge churches to assist their pastors and staff by directly contributing to their retirement plans in addition to their salaries and other benefits. Sadly, only 45% of N.C. Baptist churches and their employees participate in the Church Retirement Plan. We continue to educate and encourage our churches to be responsible employers by providing for their staff members' retirements in a Christ-honoring manner. In 2021, Don McLeod, who was North Carolina's GuideStone relationship manager, retired after many years of faithful service to North Carolina churches and their staff. In addition, CABS ministry assistant Mary Landis retired this year.

Convention Protection Benefits

GuideStone and the state convention continue to offer survivor and disability benefits to all qualified staff members of N.C. Baptist churches participating in the Church Retirement Plan through GuideStone. North Carolina continues to lead all state conventions in the number of participants, but we still fall far short of the goal of having every church providing protection benefits for their staff members by participating in a GuideStone retirement plan. In 2020, approximately 87 church staff members received \$620,000 from the state convention's protection benefits.

Tax and Health Insurance Laws

GuideStone remains a leader in providing detailed information regarding the impact that new tax and health care laws have on our churches and their staff. Timely and thorough updates of changes in the tax law are available on the GuideStone website at *guidestone.org*. We are certain that there will be many more changes in the coming months related to health care laws and the products that GuideStone will provide. The CABS office will work diligently to stay on top of these changes.

Church Staff Compensation

Because of the impact that COVID-19 and the stay-at-home orders have had on our churches, the 2020 Southern Baptist Compensation Study was postponed, and the next survey will begin in January 2022. Results of the 2018 Southern Baptist Compensation Study are available online by visiting *compstudy.lifeway.com*. However, a church utilizing the results of the 2018 Compensation Survey should consider using a general cost-of-living adjustment to make current compensation and benefit decisions for their staff. Much of our effort continues to be educating churches on the tax implications of lump sum pay packages for pastors and churches. The taxability of such pay packages continues to be a concern.

Mission Dignity

GuideStone Financial Resources continues to provide financial assistance to elderly ministers and widows of ministers who live under financial duress and need ongoing and/or one-time assistance through Mission Dignity. In 2020, individuals and entities from North Carolina contributed \$436,000 to Mission Dignity, which helped 159 North Carolina households through \$713,000 in total distributions. Due to the generosity of Mission Dignity donors, 2020 saw an increase of awards for emergency grants (\$81,000) and the annual Christmas check (\$60,000) to our North Carolina recipients. This office continues to challenge our North Carolina churches and their members to consider making Mission Dignity a part of their budget. Our goal is for North Carolina churches to financially support those faithful servants living in North Carolina.

Our staff and leadership went the "Extra" mile in every respect to keep our residents safe and secure. We are grateful for the prayers of NC Baptists that resulted in strength and increased dedication to face uncertain times.

As life at the Homes begins to thrive again, we are experiencing many new individuals and couples becoming members of our communities. For over a year we could not welcome newcomers, but with wide open arms we are delighted to see new faces and personalities become part of the Baptist Retirement Homes family. Due to the generosity of NC Baptist Churches and individuals we also continue to welcome and provide compassionate quality healthcare to many who have health issues and need Assisted Living and Skilled Healthcare. Without the help of our Baptist Retirement Homes Foundation, a significant number of these Older Adults would not be able to afford the care that they need and deserve. Your gifts truly make the difference!

For approximately 40% of our total resident population, financial assistance is a necessity. With the rising cost of Older Adult care and the challenges to many Older Adults who have outlived their savings, we count it a joy to be able to have shared in excess of \$3,000,000 in funds for those in need this past year.

In addition to the work of the Baptist Retirement Homes Foundation, our ministry seeks to touch the lives of Older Adults throughout the state in various ways. We continue to:

Partner with local churches and associations to meet needs of Older Adults living in their communities through Adult Day Respite, Nutrition, and Housing Applications programs.

Provide Baptist Chaplains located in each of our "Homes" aid in the continued spiritual journey of each resident and staff member.

Through the "Life at Home" ministry, we assist Winston Salem/Forsyth County area Older Adults with reliable, low cost handy man services.

Assist Older Adults with limited financial resources (in both institutional settings and those living in a home and community based environment) purchase the medications they need via the "Medicine From the Heart" campaign.

Every day 10,000 people in the United States turns the age of 65. North Carolina has a growing population of Senior Adults. The challenges of care for the aging are great. God birthed the Baptist Retirement Homes of North Carolina 70 years ago through the hearts of North Carolina Baptist. The

mission is still as important as it was at the beginning. Baptist Retirement Homes remains committed to serving Older Adults. It is truly a Joy!

BAPTISTS ON MISSION AREAS OF WORK

At Baptists on Mission, our Purpose is to Glorify God by involving Christians in meeting human needs in Jesus' name. We do that by offering a wide variety of opportunities for volunteers to be the hands and feet of Jesus. Everything from aviation missions where we fly patients to much-needed medical care, partnership missions, prayer ministries, medical, dental, construction, disaster relief, disaster recovery, etc.

Proverbs 3:27 reminds us, "Do not withhold good from those to whom it is due when it is in your power to do it." We want to help the people in your church be on mission, to offer hope to those in need. Because serving others in Jesus' name is at the heart of who we as Christians are supposed to be.

Baptists on Mission volunteers serve in 19 ministries that include the following:

STATE/NATIONAL/INTERNATIONAL MISSION PROJECTS

God is changing lives through mission trips sponsored by Baptists on Mission in North Carolina (mission camps, Impact NC, Disaster Rebuilds, etc.) and to places such as Pennsylvania, Hawaii, New England, Rocky Mountain Region, Appalachian Coalfields, Alaska, Guatemala, Kenya, Armenia, Romania, Hungary, Cuba, South Africa and other places. Many hundreds of volunteers serve in these partnerships every year.

Lives are being changed... The British missionary William Carey said, "Expect great things from God; attempt great things for God." Here are some of the things that we as NC Baptists have been doing to minister to people affected by Covid-19 and to glorify God:

Isolated people- We worked through NC Emergency Management to help identify people who are high risk and have food or medicine needs. More than 600 families were connected with local churches, and these churches ministered to them regularly in Jesus' name.

Food Boxes- We are so thankful to have received a USDA grant to provide Farmers to Families food boxes to families across our state. Through this grant, we were able to distribute over 1,200,000 food boxes to people in need across our state. That is approximately 30,000,000 pounds of food given in Jesus' name through churches across our state. That is around 50 million dollars worth of food! What a great way to glorify God! We were able to help churches and associations minister in their communities and bless others in Jesus' name. We were also able to work with city and county leaders, like the eastern band of the Cherokee, Jones County, and Roberson County, to provide thousands of boxes to people in need. Approximately 350 churches and community centers signed up to help distribute this food. These churches and community centers stretch across our state from Cherokee County in the West to the Atlantic in the East! Our Disaster Relief volunteers, our disaster relief leaders, drivers, and our staff worked so hard to make this possible! God has been so good to us and has provided so many opportunities to minister in His name. "Expect great things from God; attempt great things for God."

DISASTER RELIEF

God has blessed us with excellent disaster relief equipment and volunteers. North Carolina Baptists

have five large disaster feeding units. The two largest units are capable of preparing and serving 30,000+ meals per day. We now have more than 250 disaster recovery trailers (owned by local churches and associations) used to clean up and repair work after a disaster. We also have six large shower units, three laundry units, a childcare unit, several large recovery units, large generator units, and lots of other disaster relief equipment that the Lord has provided.

Lives are being changed... In September, 2018, Hurricanes Florence slammed our state and affected thousands of families. Since then, as NC Baptists, you have provided over 1,000,000 hot meals and over 50,000 volunteer days of labor to hurting people. The rebuilding from Hurricane Florence will last at least another year. Our goal is to help 2,000 families get back in their homes and to do this in Jesus' name. God blessed us with 3 rebuild centers where we can house, feed, and coordinate the work of thousands of rebuild volunteers. So far, we have helped more than 1,000 families get back in their homes. People in great need are hearing and seeing the love of Christ, and many people are coming to commit or to recommit their lives to Jesus.

MEDICAL/DENTAL MISSIONS

Baptists on Mission offer the use of the mobile medical/dental units to Baptist churches and associations as well as service organizations within North Carolina who wish to reach out to people in need. Approximately 4,000 people are seen on the two mobile units every year. Patients targeted through this ministry may include the impoverished, Hispanic, and other ethnic groups, migrant workers, fair workers, the homeless, the elderly, and more.

HEALTH SCREENING MINISTRY

A new Health Screening Ministry mobile unit arrived at the Cary office in February 2020. The new unit offers more space for individual cubicles, thus ensuring better patient privacy and a more reliable resource for the screening clinics. Our focus is on under-served, uninsured, migrant, homeless, and refugee populations throughout North Carolina. We can bring free health screenings directly to the most vulnerable patient populations and link them to follow-up resources in their own communities. Health disparities are prevalent in more impoverished neighborhoods. Our goal is to take healthcare to the most disadvantaged populations, thus improving community health navigation as we align local community health centers with patients seen at the mobile clinics. The unit's health screening tests include Hemoglobin A1C for diabetes screening, finger stick glucose, Cholestech LDX for total cholesterol and HDL results, body mass index calculation, depression screening, basic eye exams, and vital signs assessment. This ministry provides not only basic health screening clinics but spiritual assessments and counseling as well. Our hope is that by meeting a physical need, a spiritual door will be opened, and the love of Jesus can be shared.

STUDENT MISSIONS

Deep Impact helps North Carolina Baptist churches develop a comprehensive, coed youth missions strategy to produce committed followers of Christ. This strategy includes pre-packaged mission weeks, free online mission studies, weekend mission retreats, hands-on mission training, and much more. Almost 2,000 students are involved in Deep Impact every summer.

DI KIDS

One of our newest efforts is DI Kids (Deep Impact Kids), a missions weekend/week for children and their leaders. DI Kids Missions Weeks, Mini-weeks, and Weekends are pre-packaged mission experiences sponsored by Baptists on Mission. They provide elementary-age students and their leaders/parents with the opportunity to share the love of God with people in NC. The children enjoy a great camp experience with a mission focus. Involving children in missions is an excellent beginning to develop disciple-making students and adults with love for missions.

OTHER MINISTRIES

In addition to the ministries described above, other ministries of Baptists on Mission designed to equip, motivate and mobilize volunteers to be involved in missions are Agriculture Missions, Aviation

Ministry, Baptist Builders, Baptist Educators, Family Foundations, College Missions, Compassion Ministry, Church Renewal, Prayer Support, Sports and Recreation, Men's Ministry, Student Missions and Children's Missions.

MISSIONS CONFERENCE

The annual missions conference, sponsored by Baptists on Mission, includes music, testimonies, speakers, breakout sessions, mission fair exhibits, volunteer suppers, and much more. The desired end result is for participants to be spiritually renewed and inspired to become involved in missions locally and worldwide. Over 1,600 people attend this conference every year.

REGIONAL MISSIONS RALLIES

Each spring and fall, Baptists on Mission sponsors regional rallies in all 10 regions of our state. These meetings are designed to challenge North Carolina Baptists across the state to greater mission involvement and promote the September North Carolina Missions Offering. The rallies are open for all men, women, and youth interested in missions.
