#### **SYBA Fair Ministry**

The Traveling Fair Workers continue to praise our churches and the wonderful volunteers who prepare and serve the delicious homemade meals for them. They are so appreciative of the personal hygiene items they are given and for the thoughtful gift of laundry supplies. Many of the workers are Believers and welcome the opportunity to talk and pray with others about the struggles they have. They look to us for encouragement, but honestly, we are encouraged by them and their tenacity.

In 2022, 142 on-site volunteers served 674 meals on 11 days the workers were in town and provided 50 snack bags for their last night in Iredell County and for the road trip to their next destination. We shared hygiene bags with 47 of the workers, gave laundry supplies to 56 of them and another 15 received free haircuts from our talented volunteers.

This year's ministry with the Traveling Fair Workers is just a couple weeks away. We will begin serving meals on Wednesday, August 30th and finish this year's ministry with their last day in Iredell County on Saturday, September 9th. Please be in prayer for this ministry. Many of you have already committed to providing items for the special hygiene and laundry supply bags or you and your church will be preparing and serving a meal. If you would like to know more about how to be involved, please contact Mary Jane Hoover.

#### 2022 Toy Store for Jesus

The biggest ministry our association has is our *Toy Store for Jesus*. It certainly meets our value of "Do More Together" as we share the love of Jesus with families who may need help with Christmas toys for their children. The number of families and their children were higher than we had helped in the last couple of years. We had over 200 volunteers serving our Lord as they served these families. God provided ALL we needed to help 456 families with 1340 children. The ministry is located in 3 different SYBA churches over the span of 8 days. This year we also assisted families at the SYBA office for some of the parents who for various reasons missed their previous assigned appointment times. The most exciting numbers to share with you about the *Toy Store for Jesus* is the 20 Salvation decisions made for Christ, including 1 at the SYBA office! She may have been late for her appointment, but she was exactly on time to invite Jesus into her heart! There were an additional 23 who rededicated their lives to Jesus.

Thank you for understanding this ministry is not just a December event, but a year-round ministry with toys constantly being purchased, especially when great sales and clearances are offered by stores. The referral forms are sent to the school counselors we partner with as well as other ministries in late August or early September. The process of contacting the families, setting appointments for them, mailing a confirmation letter to our guests and packing the toys or sometimes even purchasing toys for special requests begins in October.

We continue prepacking the bags of toys for our guests. We began this practice in 2020 out of necessity due to COVID-19. We have found we are better stewards of God's money when we only purchase the most popular toys each year and those that are favorites year after year. The toys packed are exactly what the parent requested for their children and shared with us on their original referral forms or what

they have told our volunteers when contacted to set their appointments. Pre-Toy Store for Jesus volunteers will be needed to serve at the SYBA office beginning mid-October. Please contact Mary Jane Hoover to learn more details and to commit being one of these volunteers. Additional volunteers will also be needed beginning late October and especially in November to prepack the bags of toys for our December guests. These volunteers will be serving at the Toy Store for Jesus stock area at Troutman Baptist Church. Our hearts are burdened and know you join us in prayer for those who come to us for food for their physical bodies, but need spiritual food more than they realize.

#### 4021 - Toy Store

#### **BYLAWS OF THE**



#### SOUTH YADKIN BAPTIST ASSOCIATION, INC.

#### A NONPROFIT CORPORATION

**ARTICLE I: NAME** 

The name of the Corporation shall be the South Yadkin Baptist Association, Incorporation herein and after known as the Association.

#### ARTICLE II: MEMBERSHIP

Section 1. This Association shall be composed of regularly constituted Southern Baptist Churches who have been duly accepted into membership by the Association. Participating member churches may empower the Pastor and up to two other representatives to vote on matters at the Annual Session or other special called meetings.

Section 2. The Association shall be sole judge of its membership and may receive or reject churches applying for membership therein at its pleasure, provided that the churches so received shall agree to come under watch care of the Association for a period of one year. During this period of watch care, such church or churches shall be entitled to all the rights and privileges of the Association except that of their members voting and holding office. At the conclusion of this period, should no objections be raised, they then, upon recommendation of the Board of Directors, would be presented to the Association for membership in regular standing by action of the Association in Annual Session.

Section 3. The Bible shall be accepted as the sole guide in matters of doctrine and practice, and the Association shall reserve the right to withdraw fellowship from any church that does not conform thereto.

Section 4. The SYBA takes it seriously when a church neglects to handle reported sexual abuse. The SYBA may choose to withdraw from any church that fails to protect victims and handle sexual abuse among their ministers, members, and staff.

#### ARTICLE III: PURPOSE

The primary purpose of this Association shall be to counsel together for the advancement of the cause of Christ for the promotion of unity and growth among the churches composing the Association; furthermore, it is the

purpose of this Association to cooperate with the Baptist State Convention of North Carolina and the Southern Baptist Convention and their agencies in the work of missions, Christian education, and social ministries.

#### ARTICLE IV: POWERS AND PREROGATIVES

The Association shall have no power whatever to infringe upon the autonomy of the churches. It may advise or recommend measures of guidance for their adoption but cannot bind them in any way. All the churches constituting the Association remain sovereign and independent bodies and unite that they may more effectively promote the cause of Christ throughout the world.

#### ARTICLE V: DUTIES OF THE CHURCHES

Section 1. It shall be the duty of each church to select representatives and to encourage their attendance at the Annual Sessions of the Association (See Article II: Section 1.)

Section 2. Each church shall send annually a report, the Congregational Profile, to the Association giving information requested. This information, in turn, will be shared with the Baptist State Convention of North Carolina and the Southern Baptist Convention.

Section 3. Each member congregation is expected to financially support the Association. It is recommended that each member congregation establish a certain percentage of their undesignated receipts to be forwarded to the Association monthly.

Section 4. Each member congregation is expected to participate in the ministries and the mission activities of the Association.

#### ARTICLE VI: ORGANIZATION

Section 1. The Board of Directors of the Association shall be a President, Vice-President, and five Board members, who shall be elected at the Annual Session. The Associational Clerk and the Associational Executive Director shall serve as ex-officio Board members and shall serve at the pleasure of the Association. The Board of Directors shall recommend all officers to be elected by the Association in the Annual Session.

Section 2. All officers shall be members of churches affiliated with the Association.

#### ARTICLE VII: DUTIES OF OFFICERS

Section 1: It shall be the duty of the President to preside when the Association is in session and in other

meetings as provided for in these Bylaws.



## Section 1: It shall be the duty of the President to preside over the Business Meeting at the Annual Associational session and in other meetings deemed necessary provided for in these Bylaws.

Section 2. It shall be the duty of the Vice President to preside in the absence of the President and to assist the President in every way possible.

Section 3. It shall be the duty of the Clerk to keep an accurate record of the Session of the Association and prepare minutes to be distributed within two months after the Annual Session or as soon thereafter as possible.

Section 4. The Board-designated Financial Officer shall be responsible for an accurate account of all money paid into the Association, payment of corporate obligations, shall make regular reports to the Board of Directors and make an annual report to the Association. The Board of Directors shall enlist the services of a CPA to conduct a financial review every three years. Such cost being reimbursed by the Association.

Section 5. It shall be the duty of the Clerk to collect and preserve minutes of each session of the Association and to collect and preserve records of the history of our Association.

Section 6. Any vacancy which occurs in the Board of Directors shall be filled by the Board of Directors.

#### ARTICLE VIII: RULES OF ORDER

In the absence of the President, the Vice-President shall preside at all regular meetings. All officers shall faithfully discharge the duties pertaining to the office to which they have been elected. The following rules shall govern deliberations:

- 1. All business shall be conducted, and all discussions shall be carried out in a Christian manner as prescribed in the Scriptures.
- 2. The method of voting shall be by the will of the body. The simple majority shall prevail in all cases, except as otherwise designated by the Board of Directors.
- 2. The method of voting shall be by the will of the body. A simple majority shall prevail in all cases except where a vote by two thirds majority is required by these bylaws.
- 3. A ruling by the presiding officer shall be final unless appeal be made from such rulings to the entire body present.

#### ARTICLE IX: TIME OF MEETING

The Association shall meet annually in August; however, in the case of some unavoidable circumstances that make a change in the date necessary, the Board of Directors is empowered to make such a change. The Board of Directors shall have the authority to call a special meeting of the Association should the need arise.

#### ARTICLE X: THE ASSOCIATION YEAR

The fiscal year shall begin with the first of September of each year and close the following August 31.

#### ARTICLE XI: BOARD OF DIRECTORS

- 1. <u>Membership</u>. The Association shall have at least seven (7) Directors. The seven (7) Board of Directors shall consist of President, Vice President, and (5) five other Board members who shall be elected at the Annual Session. These officers will be elected by the Board annually. The seven (7) duly elected Board of Directors can designate additional at-large Directors as deemed necessary.
- 2. <u>Duties</u>. The Board of Directors shall have general control of the affairs, funds, and property of the Association and shall determine policy and establish guidelines for the effective conduct of the business affairs of the Association. It shall be responsible for the accomplishment of the organization's purposes and



objectives and shall present to the membership all proposed major program activities for ratification. The Board of Directors shall recommend the officers of the Association herein described.

2. <u>Duties</u>. The Board of Directors shall determine policies and establish guidelines for the effective conduct of the business affairs of the Association. The Board of Directors shall recommend the officers of the Association. The Board of Directors in partnership with the Executive Director shall be responsible for the accomplishment of the organization's purposes and objectives.

In the case of the vacancy of an Executive Director, the Board of Directors will select an interim in search of a permanent director. Once a director has been selected by the Board, of those present and voting, a vote of two thirds majority from the churches of the Association may ratify the election of such a director. All other hirings needed by the Association will be handled within the regular Board meetings of the Board of Directors.

In the case of the termination of an Executive Director, the Board of Directors will convene and prepare a meeting to be held with the churches of the Association requiring of those present and voting, a two thirds majority vote for termination. All other hiring and terminations will be handled by the Board of Directors if a need arises.

When the Board of Directors finds the need to buy, sell, or acquire property for the Association, it may call a meeting of the churches for their input of such a sale or purchase, and will require of those present and voting, a two thirds majority vote.

- 3. Fiscal Powers. The Board shall oversee the budget for each fiscal year.
- 4. <u>Term of Office</u>. The Directors shall be elected annually. They will serve rotating 4-year terms and must be off the Board for 1 year before they are eligible to serve another term. Vacancies occurring between annual sessions of the Association shall be filled by the Board of Directors.
- 5. Removal. Any Director may be removed without cause by a majority vote of all other Directors.

#### ARTICLE XII: CALLED OR SPECIAL MEETINGS

1. Special meetings of the Board may be called by the President, Vice-President, the Executive Director, or any three (3) Directors. Special meetings shall be held on four (4) days notice by first-class mail, postage prepaid, or on forty-eight (48) hours' notice delivered personally, by telephone, or by electronic mail. Notice

of the special meeting need not be given to any Director who signs a waiver of notice or a written consent to holding the meeting or an approval of the minutes thereof, whether before or after the meeting, or who attends the meeting without protesting, prior thereto or at its commencement, the lack of such notice to such Director. All such waivers, consents, and approvals shall be filed with the corporate records or made a part of the minutes of the meeting.

- 2. <u>Time and Place</u>. The time and place of the meetings of the membership shall be as specified by the Board of Directors.
- 3. <u>Special Meetings</u>. Special meetings of the Association may be called at the request of a majority of the Board of Directors.
- 4. <u>Notice of Meetings</u>. The Clerk shall notify each member of the time and place of all meetings called for by the Board of Directors. Such notification may be written or verbal communication with the membership.
- 5. Quorum. A simple majority of the members present at a meeting shall constitute a quorum at membership meetings.
- 5. Quorum. A quorum will consist of at least 4 of the 7 Board members present at a membership meeting, whether in person or by a virtual video meeting, to vote on business pertaining to the Association.

#### ARTICLE XIII: LIABILITY

The private property and assets of members of the Board of Directors, officers, committee members, employees, and agents of South Yadkin Baptist Association, Inc., shall forever be exempt from liability for its debts, obligations, and lawsuit and shall be entitled to indemnification as provided for by N.C.G.S. 55 A-8-50, et seq.

#### **ARTICLE XIV: NET EARNINGS**

No part of the net earnings of the organization shall inure to the benefit of its members, directors, officers, or other persons except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the exempt purposes of the organization.

**ARTICLE XV: ADOPTION** 

These Bylaws shall take effect immediately upon its adoption and shall supersede any and all Bylaws previously adopted.

#### ARTICLE XVI: REVISION

These Bylaws may be immediately revised at any session of the Association by a vote of two-thirds of the representatives present.

#### ARTICLE XVII: CORPORATE SEAL

The Corporate Seal of the Association shall consist of two concentric circles between which is the name of the Association and in the center of which is inscribed the word "SEAL" and such seal, as impressed on the margin hereof, is hereby adopted as the Corporate Seal of the Corporation.

These bylaws were affirmed at the SYBA Annual Meeting held August 17, 2021.



This is a Continuing Care at Home program for independent adults who want to age in place. The Baptist Retirement Homes Foundation is proud to support ThriveMore in their endeavors, and are thankful for the support and encouragement we have received for over 70 years. We thank you for answering God's call to give to those in need of care. Baptist Retirement Homes Foundation gives 100% of every dollar donated directly to resident support, a feat that most nonprofits are unable to achieve. #### BAPTIST CHILDREN'S HOMES OF NORTH CAROLINA

Who we are: Since 1885, the heart of Baptist Children's Homes (BCH) has beat with a rhythm of hope that extends throughout North Carolina, South Carolina and Guatemala. For each person's specific need, we offer a unique ministry ready to help. It is only through the providence of God and being *on mission together* with NC Baptists throughout the state that we are able to minister to the myriad of needs and share God's love with those we are privileged to serve. We are many ministries beating with one heart -- the heartbeat of Jesus.

**Did you know:** God has grown BCH from its roots as an orphanage to a sprawling non-profit organization that ministers to others from the first heartbeat to the last.

- BCH has locations in more than 35 communities in NC, SC and in Guatemala.
- BCH impacted 167,619 lives in 2022 through the support of NC Baptists.
- 80% of those we serve come to BCH unchurched and unreached for Jesus.
- There have been 661 professions of faith throughout the past five years.
- Through the **EVERY CHILD Foster & Adopt Initiative**, a partnership between BCH and NC Baptists, we train and license Christian couples to be foster families. We help churches to begin their own foster care ministries. There are more than 10,000 (*Data from morethanenough.cafo.org*) NC children in the state's foster care system who were removed from their homes for their protection. We believe the church is the answer for connecting children with caring, Christian homes. *Visit every-child.org* 
  - Also through EVERY CHILD, BCH's Christian Adoption Services aids couples
    with domestic and international adoption and ministers to expectant mothers to
    show them the beauty of choosing life for their babies by helping them make an
    adoption plan. Visit christianadopt.org
  - The total number of foster homes licensed: 354. The total number of foster children served in BCH foster homes: 725.
  - O Domestic adoptions have increased 41% compared to this time last year.
- BCH oversees an orphanage and cottage homes at Good Shepherd Ministries in Xela, Guatemala providing care to indigenous boys and girls who are abused and neglected.
- The ministry provides homes for intellectually/developmentally disabled adults.
- BCH operates the North Carolina Baptist Aging Ministry (NCBAM) serving senior adults. *Visit ncbam.org*
- It offers 24/7 residential wilderness camp ministries that are accredited, non-public schools. *Visit cameronboyscamp.org and campduncannc.org*
- BCH provides a supportive home for teen mothers and their babies.
- Family Care offers a residential program for single mothers needing support.
- Greater Vision Outreach aids immediate needs of community families in crisis and connects them with resources to achieve long term stability.
- HOMEBASE offers resources to college students with little to no family support.

#### Highlights and Future Efforts:

- Tirrell Discovers Family & Freedom, Accepts Christ: From isolation to salvation, Tirrell is experiencing family and freedom for the very first time. For years, he was confined in his childhood home never attending school and only being fed rice. His extreme situation was not discovered until he was almost a teen. Now, he has found his family through John and Erin Stuebe who were trained and licensed as foster parents through the EVERY CHILD Initiative, a partnership between BCH and NC Baptists. Through the couple's discipleship and church involvement, Tirrell accepted Christ on June 16. Tirrell's story is the focus of the Annual Offering. The Week of Prayer is November 5-12. The new video and offering resources are at bchoffering.org
- Emmanuel Home Welcomes First Resident: The new residential ministry for mothers who have chosen adoption for their babies, has its first resident. This birth mother comes from Eastern NC and has no family support. She found a job almost immediately.
- NC Baptists throughout the state collected more than \$500,000 in food, supplies and gift cards through the annual "Food Roundup."
- Bikers participating in "Ride to Clyde," the statewide motorcycle ride organized in partnership with NC Baptists, raised a record \$178,002.00.
- Efforts are in place for a new collaboration between BCH's Intellectual & Developmental Disabilities Ministry and NC Baptist Aging Ministry (NCBAM). This will bolster each ministry and continue to grow our services to the local community including the aging population as well as families with special-needs members.
- Two new Innovations in Special Needs Ministry: The first new effort is known as "Special Homes for Special Adults," known in the Intellectual and Developmental Disabilities (IDD) field as Alternative Family Living. This is where families or individuals open up their homes for a special needs adult to live. A family in Greensboro will be the first within this new model of care. The second new effort are Inclusion Classes at the Weekday Education center in Thomasville, one of the few places serving special needs children. Inclusion Classes are designed to mix special needs children with typically developing boys and girls so they help each other learn and grow.
- NC Baptist Aging Ministry (NCBAM) opened the first of its **new "Care Villages"** at BCH's Kennedy Home in Kinston with help from the Neuse Baptist Association and area churches. Plans are in place for a Care Village at the Baptist Convention building in Cary. NCBAM works with churches, aging-service providers, and others to bring services to Care Village members living in their own homes. This allows them to age "in community." *Learn more at ncbam.org*.

#### Report of the Associational Partnerships Catalysts for 2023

The Associational Partnerships Catalysts serve in a part-time permanent role to partner with the Associational Missions Conference Leadership Team, Associational Mission Strategists and Associations to develop and offer leadership, strategic and operational training across North Carolina. Serving in the three respective areas of the state, each catalyst works with each individual AMS as well as Associational Search, Vision and Strategy Teams. Regional AMS Roundtables meeting frequently offer another layer of connection for resources and relationships. Another important and powerful component introduced this year continues to be training of the Leadership Library and Pipeline with the help of Marcus Redding. The next phase of the Pipeline is to equip AMSs to share this tool with their pastors.

We are grateful to and for our Executive Director-Treasurer, Dr. Todd Unzicker, who engages our AMSs across the state frequently through the use of Zoom calls in order to keep a personal connection and offer updates and resources.

The 2023 North Carolina Associational Missions Conference was held at Caraway Conference Center April 17-19, 2023. During the training for Potential and New AMSs offered on Monday morning, information was shared regarding support organizations who offer additional training and resources, a panel discussion with three veteran and three new AMSs addressing "Best Practices and Wisdom for Getting Started Well," and overview of the role of Associational Missions.

The following early bird sessions open to potential and current AMSs were offered: Roy Smith focused on "Pastor Search Team Tools" while Marcus Redding facilitated training regarding the "Multiplication Pipeline."

AMS Spouses offered a track focusing on "The Hand of God – Trusting Him in The Waiting." Matthew and Danielle Kelly lead the spouses in prayer and worship. Cynthia Marks was the speaker.

The theme for the main conference focused on "Regaining Movement." Dave Rhodes, Clarity House, lead through the following four sessions: "Regaining Movement: Name the Problem," "Regaining Movement: The Disciple's Journey," "Regaining Movement: How to be a Leader that is Easy to Follow," "Regaining Movement: Helping Churches Identify and Take Their Next Best Step." Our Executive-Director Treasurer, Todd Unzicker, opened the conference as our first speaker. Bob Lowman, AMS Metrolina Association, and Kenny Lamm lead the times of prayer and spiritual emphasis. Representatives from the NC Family Policy Council, SEBTS, Baptist Children's Homes, Baptist on Mission and Saturate USA shared information with the AMSs.



#### Biblical Recorder Annual Report

This year has been active for the Biblical Recorder (BR). In the past 12 months, we have:

- Implemented a management agreement with the Baptist State Convention of North Carolina that went into effect July 1, 2022, to ensure continual local news coverage for North Carolina Baptists.
- Continued to produce a printed magazine, weekly newsletter and active website presence highlighting local and national Baptist news.
- Assisted the state convention's board of directors in commissioning a study committee to help discern the next steps for the long-term strategy of the BR.
- Enhanced our social media presence across several platforms.
- Filled open staff positions and roles.

Led by Managing Editor Chad Austin, the *BR* staff team has worked hard to provide a continual stream of trusted news coverage for North Carolina Baptists in print, online and through social media. This has included timely coverage of news, events and happenings in N.C. Baptist life, feature stories on people and ministries across North Carolina, and content that adds insight, perspective and analysis of how national issues and trends impact N.C. Baptists. The staff has also been providing in-depth updates via a weekly email, all while producing a consistent, quality magazine on a regular basis.

At the time of this writing, the *Biblical Recorder* team and board of directors are awaiting the study committee's report and recommendations to help inform and guide the next steps for the *BR* moving forward.

Even across mainstream media channels, journalism looks very different than it did five years ago. Many struggled to be financially viable before the pandemic, and this trend only accelerated in 2020-2022. It is estimated that two newspapers shut down nationally every week.

While the stats are sobering, there has never been a time when a trusted source of news is more needed for North Carolina Baptists than today, and we look forward to continuing to provide that service in the months and years ahead.
